### 3. AIMS AND OBJECTIVES:

1. To organize consumer awareness, Health camps, sanitation programs and AIDS/HIV awareness programmers in rural, urban and tribal areas.
2. To establishment of hostels for poor children, street children homes, old age homes, old widow Homes and Orphan Homes. Development and welfare of women and children.
3. To promote self-help economic development programmes by providing the integrated services and facilities for increasing employment, production and income.

### RULES AND REGULATIONS

1. Name of the Association: SRI A S N M GOVERNMENT COLLEGE AUTONOMOUS  
OLD STUDENTS ALUMNI ASSOCIATION
2. Location of office : D.NO. 32-6-4/1, DEVUNI THOTA, PALAKOL-534200  
WEST GODAVARI DISTRICT, ANDHRA PRADESH

### 3. MEMBERSHIP:

The membership shall be open to all who are interested in promoting the society to achieve its aims and objects. But the membership shall be approved by the managing committee. Persons who want to become members of the Society shall pay an amount of Rs.100/- towards admission fees. After obtaining the membership every member shall abide by the rules and regulations, Resolutions passed by the Managing Committee as well as those of the General Body. The President has power to receive subscriptions, donations grants, gifts by Way of movable or immovable properties (received with in India or abroad). He has power to acquire the movable or immovable properties, safeguard them and give them to lease or rent for the benefit of the Society.

### 4. TERMINATION OF MEMBERSHIP:

- a) Those who resign in writing and whose resignations are accepted by the President.
- b) Those who fail to attend three consecutive meetings of the Society in Succession.

Those who forfeited their membership thus can rejoin as members subject to the approval of the President on payment of such fee as is determined and with in the time laid down by him.

### 5. GENERAL BODY AND ITS FUNCTIONS:

A General body meeting of the Society will be held in December every year. During which the following items of work will be transacted:

- a) To elect members of the Managing Committee or confirm them.
- b) To approve the report of the activities of the Society.
- c) To pass the budget for the ensuing year and approve the expenditure statement of the previous year.
- d) To appoint an Auditor to audit the Society Account.
- e) To transact any other matter for the benefit of the society.

For extraordinary and special meeting the Secretary with the consultation of the President shall, on the motion of 3/5<sup>th</sup> members from the Managing Committee or on the requisition of 3/5<sup>th</sup> members General Body convene a meeting of General Body. Ten days notice shall ordinarily be given to members for the General Body Meeting. Two days shall be given to members for extraordinary and special purpose.

## **6. MANAGING COMMITTEE:**

The Managing Committee shall consist of ..... Members i.e. President, Vice President, Secretary, Joint Secretary, and Treasurer and ..... E.C. Members. The members of the society shall be elected by the General Body once in 1 year. Any interim vacancy in the Managing Committee shall be filled up by the president. The managing Committee shall meet at least once in two months or on the day notified by the Secretary with the consultation of the President. The Managing Committee shall have power to change bye-laws not inconsistent with the rules for the regulation of the business of all sections of the society subject to the approval of the General Body at its next meeting. The Committee shall exercise general control over the activities of the Society. The Committee shall arrange for holding the Annual General Body Meeting and conferences and take all steps for implementation of the decisions of the Society.

## **7. DUTIES OF THE OFFICE BEARERS**

### **PRESIDENT:**

He shall preside over all the meetings of the both General Body and Executive Committee, He shall have the casting vote in case of tie in the meetings. He can supervise all the branches of the society.

### **VICE PRESIDENT:**

In the absence of the president, the Vice-President shall act as president with the permission of the President. He will assist the president in the activities of the Society.

### **SECRETARY :**

The Secretary shall convene all the meetings of the Society. He shall be responsible for Carrying into effect, the resolutions of the General Body as well as those of the Managing Committee. He will keep the records of the Society with safe and secure. He will prepare the Annual Report of the Society and place it before the president for inspection and then get it approved by the Annual General Body.

The Secretary has the following powers also

- a) To appoint , dismiss suspend or otherwise punish any salaried employees of the Society and to all or any of them furnish security.
- b) To accept the resignation of members.
- c) To sanction all the contingent expenditures of the Society.
- d) To supervise the punctual payments of fees etc.,
- e) To take policy decisions from time to time in order to create better facilities to the members and better amenities to staff and members.
- f) To take such suitable steps as and when necessary to augment the financial and economic positions of the Society and for the benefit of members and staff.
- g) To make such rules for the internal management of the Society as it may think fit, subject to the confirmation of the General Body.
- h) Every major expense shall be incurred only by the President with the previous sanction of the Managing Committee.
- i) To shift the location of Office and appoint sub-Committee whenever it is felt necessary.
- j) To transact any other matter for the benefit of the society.

**JOINT SECRETARY:**

He shall carry out instructions of the Secretary from time to time and assist him in all his duties and in the absence of the Secretary, he will exercise or carry out the powers and duties of the Secretary.

**TREASURER:**

He will maintain proper accounts of the Society. He will keep the funds of the Society with the Banks, Post Offices, Societies, as per the directions of the President and secretary. He shall be entitled to collect the funds, subscriptions etc., for the society. When withdrawing any amount from the Bank, Post Office for Society the cheque shall be signed by President and Treasurer.

**COMMITTEE MEMBERS :**

They will attend to the affairs of the society as per the directions of the Managing Committee. They will do other works relating to the Society and strive for the development of the Society.

**FINANCE OF THE SOCIETY:**

1. The funds of the Society and its projects shall consist of voluntary contributions, gifts, grants, assessments, fees or any payments received for the services rendered, or any funds received from any other source for carrying out its objects.
2. The funds of the Society shall be spent for the attainment of the objects of the society. Whatever source they may be it should be kept with the financial structure adopted by the Governing Body.
3. The investments of the Society shall be made in accordance with the provision of "The Income-Tax act, 1961" (as may be amended from time to time). The Society shall have the authority to open and close accounts with one or more scheduled banks and shall be operated jointly by the President and Treasurer.
4. The Accounts of the Society shall be audited by a qualified Chartered Accountant.
5. April to March shall be the financial Year of the Society.

**9. INCOME TAX EXEMPTION:**

To approach Income Tax authorities of Commission rate and state authorities to apply for Income Tax exemption 12A, 80-G (5) (Vi), 35AC, 35I&II for receiving donations which are exempted from income Tax.

**10. F.C.R.A**

All the participants unanimously given their acceptance to approach Govt. of Indian officials to get F.C.R.A. Certificate.

**11. BANK ACCOUNT:**

Bank Accounts is opened in any schedule bank or banks in the name of the Society and can be operated with joint signature of President and Treasurer.

**12. LOANS:**

The Secretary is empowered to take Bank Loans, mortgage and Bank guarantees by pledging the movable and immovable properties of the Society, after approval of the Governing Body and President.

**13. TENURE:**

The elected members of the Executive Committee shall hold office for a term of 1 years from the date of election or until Fresh Election takes place whichever event occur later.

**14. VACANCIES:**

Whenever any vacancy in the Executive Committee arises, the Executive Committee shall co-opt from among the members of the General Body and such co-opted members or members shall hold office for the expire period of vacancy.

**15. QUORUM :**

The attendance of 3/5<sup>th</sup> of members of General Body Meetings and of 3/5<sup>th</sup> of Executive Committee meeting will constitute the Quorum. A meeting will be adjourned when there is no quorum. When two successive meetings are so adjourned for want of quorum, a third meeting can transact business even though there is no quorum.

**16. FUNDS:**

- a) The funds of the Society shall be spent only for the attainment of the objects of the Society and no portion thereof shall be paid or transferred directly or indirectly to any of its members through any means.
- b) The Bank Pass book and cheque book shall be kept with the President and the cheque book can be operated by the President and Treasurer.

**17. PROPERTIES:**

The Properties movable or immovable vested in the name of the Society shall be represented by the President.

**18. SUITS:**

The Society shall sue be sued in the name of President.

**19. AMENDMENTS:**

No amendment to the constitution shall be made unless it is voted by 3/5<sup>th</sup> of the total members of the General Body at the meeting convened for the purpose and confirmed by 3/5<sup>th</sup> of the members present at a second special meeting.

**20. MISCELLANEOUS:**

- a) The Managing Committee shall have power to elect the ex-official members whenever necessary for the development of the Association.
- b) The society shall function according to the convenience of the members and as per the directions of the Secretary with the consultation of the President.

**21. COMPLAINTS AND DISPUTES:**

- a) Members desirous of making complaints or proposals in regard in any branch of the management of economy of the Association may address the Secretary or record in the complaint book maintained for the members.
- b) All complaints or proposals shall be considered and disposed off by the Secretary in the best of his discretion and the result only communicated to the member's concerned.

**22. WINDING UP:**

In case the society has to be wound up, the property and funds of the Society that will remain after full satisfaction of the liabilities of the Society will be transferred or paid to some other institution with similar aims and objects.



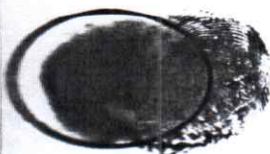
