ORDER:

During the year 1968-69 the Govt. have started 6 Govt. Mak Arts & Science Colleges at Guntakal, Razole, Tanuku, Palakol, Visakhapatnam and Srikakulam. During the current year it is proposed to open 1st year of the three year degree classes besides the opening of 1st/2nd year Intermediate course in the aforesaid colleges. In this connection the Director of Public Instruction in his Lr. read above has submitted proposals for sanctioning additional staff and expenditure (both recurring and non-recurring) not exceeding Rs. 7,91,063/- for the period from 1-8-69 to 28-2-1970 during the ~~SYNTHETIC~~ current year.

2. After careful consideration of the proposals of the Director of Public Instruction the Govt. accord sanction for the additional staff (both teaching and non-teaching) as far detailed in the annexure to this order from the date of appointment to the posts till 28-2-1970. The staff is eligible to draw the usual scales of pay and allowances admissible under rules.

3. Sanction is also accorded to the incurring of a recurring expenditure of Rs. 2,102,018/- towards the additional staff and also a non-recurring expenditure of Rs. 3,90,000/- as detailed in the annexure in respect of the 6 aforesaid colleges.

4. The annexed expenditure on this account shall be a first charge in the Education Plan for 1970-71 and to this extent the proposals for sanctioning other schemes will not be entertained.

5. The expenditure sanctioned in para(3) above shall be debited to the following heads of accounts:-

i) In respect of the staff employed for starting additional sanctions and courses in Govt. Arts & Commerce Science Colleges for Men Andhra:-  
" 26 Education - A. University (5) Govt. Arts Colleges Schemes included in the IV five year plan - 1(i) Arts Colleges for Men, Andhra - 3 - Opening of next higher classes in New Govt. Colleges started in 1966-67.

ii) In respect of Govt. Arts & Science Colleges for Women " 26 Education - A. University (b) Govt. Arts Colleges Schemes in the IV Five Year Plan I (i) Arts Colleges for Women, Andhra - 2 Opening of new colleges for general education during '66 -

iii) In respect of staff employed for 2 year Intermediate courses in Govt. Arts & Science Colleges for Men in Area:-

" 28 Education - A University (b) Govt. Arts & Science Colleges Schemes in the IV Five Year Plan I (i) Arts Colleges for Men - Andhra - 5 Introduction of 2 year Intermediate course ~~and~~ in the existing degree colleges and in selected Higher Secondary & Multipurpose Schools".

iv) In respect of staff employed for 2 year Intermediate Courses Govt. Arts & Science Colleges for Women in Andhra area:-

6. As regards the sanction of expenditure to the colleges on contingencies and T.A. in the D.P.I. is requested to send separate proposals immediately keeping in view of the requirements of each college during the current year.



ORDER:

During the year 1968-69 the Govt. have started five new Govt. Colleges at Visakhapatnam, Basole, Tanuku, Palakol and Srikanthaswamy Srikalahasti(Women) with Pre-University courses. I, and II Year degree classes have been opened progressively in these colleges during 1969-70 and 1970-71 and that III Yr. Degree classes have to be opened during 1971-72. In this connection the Director of Public Instruction has submitted the proposals for sanctioning additional staff and expenditure(both recurring and non-recurring) Rs.4.63 lakhs for the period from 1.9.71 to 29.2.72).

After careful consideration of the proposals of the Director of Public Instruction the Govt. accord sanction for the additional staff(teaching staff only) as detailed in the Annexure to this order from the date of appointment to the posts till 29.2.72. The staff is eligible to draw the usual scale of pay and allowances admissible under rules.

Sanction is also accorded to the incurring of a recurring expenditure of Rs.2,19,592 towards the additional staff and recurring contingencies and a non-recurring expenditure of Rs. 10,000/- towards equipment, furniture, and books and payment of pending bills in respect of the aforesaid 5 colleges as detailed in the Annexure.

4. The expenditure sanctioned in Para 3 above shall be debited to " 28 Education - A. University - Schemes included in the IV Five Year Plan(b) Govt. Arts College(i) Arts Colleges Non-Andhra-I Improvement of existing colleges(Govt.)".



In the light of the instructions contained in the references read above, it has been observed that in some of the Government Degree Colleges, certain teaching staff are working without having adequate workload and in some of the Government Degree Colleges, due to dearth of staff, the students are suffering from not having regular lecturers. To prevent this, to upgrade the educational needs in all Government Degree Colleges and to have equilibrium in academic growth, the Commissioner of Collegiate Education has decided to follow rationalization of vacant surplus Lecturer Posts, and by converting / retaining / shifting to the other needy Government Degree Colleges.

Therefore to avoid such prevailing situation in the Colleges, to have equilibrium in academic growth for the benefit of student community after a thorough verification and scrutiny of the workload particulars submitted by the Principals of Government Degree Colleges with reference to the student admission particulars of their respective Colleges, while exercising the powers conferred in the references 1<sup>st</sup> to 3<sup>rd</sup> read above, the Commissioner of Collegiate Education has hereby decided to rationalize the vacant surplus Lecturer Posts, by converting / shifting to the other needy Government Degree Colleges or retaining in the same College by converting the posts to that of posts as mentioned against each subject, as per the Annexure enclosed to these proceedings.


